Class 1. Any person who is a recognized agent of a motor vehicle manufacturer or a seller of motor vehicles made by such manufacturer whose authority to sell the same is created by a written contract with such manufacturer or with some person authorized in writing by such manufacturer to enter into such contract, and whose principal business is the sale of new motor vehicles, the purchase and sale of second hand motor vehicles being incidental or secondary thereto, may be granted an agent's or a seller's license; provided, that with respect to second hand motor vehicles purchased for the purpose of sale or exchange and not taken in trade for new motor vehicles, such dealer shall be subject to all provisions of this chapter applicable to holders of licenses of Class 2, except subsection (c), and to rules and regulations made under those provisions; and provided further, that such dealer maintains or demonstrates access to repair facilities sufficient to enable him to satisfy the warranty repair obligations imposed by section 7N1/4 of chapter 90, and shall remain liable for all warranty repairs made and other obligations imposed by said section 7N1/4 of said chapter 90.

<u>Class 2.</u> A person whose principal business is the buying or selling of second hand motor vehicles, a person who purchases and displays second hand motor vehicles for resale in retail transactions, and any other person who displays second hand motor vehicles not owned by him pursuant to an agreement in which he receives compensation, whether solely for displaying the vehicles, upon the sale of each vehicle, or otherwise, may be granted a used car dealer's license.

<u>Class 3.</u> A person whose principal business is the buying of second hand motor vehicles for the purpose of remodeling, taking apart or rebuilding and selling the same, or the buying or selling of parts of second hand motor vehicles or tires, or the assembling of second hand motor vehicle parts may be granted a motor vehicle junk license.

AUTO LICENSE APPLICATION PROCESS

Applicant submits the auto license application to the Board of Selectmen.

The application is sent for review and comments to the following Town Departments: Health, Inspection, ZBA, Planning, Conservation, Police Fire.

The Board of Selectmen reviews the application and Department comments at one of their meetings, and if the application is approved by vote of the Board of Selectmen, the license will be prepared and signed by the Board subject to the following conditions:

- A. The applicant submits a \$25,000 bond in accordance with Mass. General Laws Chapter 140 Section 58 from a surety company licensed to do business in the Commonwealth of Massachusetts
- B. The applicant submits a completed Worker's Compensation Affidavit
- C. The applicant submits a \$200 application fee in the form of a check made payable to the Town of Rowley

The license will not be released to the applicant until the conditions above are met.
